Procedure of Conducting Election of Lay Delegates to Jurisdictional Conference

The process of electing lay delegates to the 2024 Jurisdictional Conference is open to any interested individual. However, through the Delegate Profile Booklet lay delegates voting members are better informed about the qualifications of persons who have specifically expressed an interest in being elected. Balloting and counting will be quicker and more accurate.

Procedural Steps:

- All interested individuals were invited to submit photographs of themselves together with brief resumes for inclusion in this booklet to be distributed to all lay delegates to Annual Conference. This booklet has been prepared and is being sent via email blast to all lay delegates as an addendum to the Pre-Conference Journal. The availability of the resumes and photos of persons interested in serving as delegates to the 2024 Jurisdictional Conference will enable all lay delegates to Annual Conference to study individual qualifications and vote more intelligently.
- 2. The voting procedure will be as follows:
 - A. Each person listed in the distributed booklet will be assigned an identifying number for use in the voting process.
 - B. Lay persons not in the booklet will have an opportunity to submit their name for the election process at the Laity Session of the Annual Conference.
 - C. Ballots will be tallied by our TAC Tellers, (Lance Richards is the Head Teller):
 - i. Following the voting session the Laity Session will move through its agenda, stopping at appropriate places in the agenda for the tally announcement and submitting of the subsequent ballot.
 - ii. When a delegate is elected, the newly elected delegate's name will be added to the list of 2024 Jurisdictional Conference Delegation on one of the screens at the front of the Grand Ballroom.

What do you believe God is calling the United Methodist Church to do in the near future?
 I believe God is calling the UMC to strengthen its resolve to remain faithful in connection and focus shared resources to respond to the needs and dreams of communities worldwide. The UMC is called to be transformational, healing and joy filled. Even when challenged by questions of policy, structure and rules, we are called to remember that these questions arise from a responsibility to one another, to the mission of the UMC, and our calling as Christians.

2. What do you believe are the most important issues facing General Conference?

Our conferences are facing the need for 1) recommitment to the work and life of the church together in response to God's call to all of us in the UMC; 2) renewed commitment to the organization and processes that provide guidance, structure and stewardship; 3) revision of processes and structures that prevent or hinder full engagement in ministry and mission; 4) thorough discernment and dedication to resolving stewardship challenges before us.

3. Share briefly why you want to serve as a delegate.

I can offer skills and experiences that could be helpful during this time of crisis and restoration. I recently served as a part of the group of clergy and laity organizing That We May Be One (TWMBO), which has shown how the church will rise to the challenges before us. In my career in the oversight, fiscal responsibility, ethics and regulation of biomedical research with both The University of Texas Health Science Center and now with Baylor College of Medicine in the Texas Medical Center I have led and engaged in teams charged with a broad range of ethical, fiscal, regulatory and process related goals in complex health sciences settings. All of these efforts require discernment, engagement, dedication and care. In short, think I can help.

I have served as a lay delegate to the TAC for over a decade and most recently as a part of the group of clergy and laity organizing TWMBO. 1. What do you believe God is calling the United Methodist Church to do in the near future? Having undergone a period of separation/disaffiliation, it is time for profound intentional prayer. I believe God is calling UMC to "re-set" from distractions that impede evangelism and mission. The word of God is very clear as He calls UMC by supplication (II Chron. 7:14 (NLT). UMC is called to set and/or strengthen its priorities, communicate them widely, establish a culture of accountability and attend to the business of Gods calling. As the lawmaking body of UMC, all decisions, laws, policies etc. are to be in accordance with the assertion "Choose this day whom you will serve" Joshua 24:15.

2. What do you believe are the most important issues facing General Conference?

I believe issues faced by General Conference (GC) are the need to: ensure unified, shared vision; resolve any remaining vestiges of its position on homosexuality; review fiduciary outcomes that may have resulted from separations; and adopt unequivocal and bold policies and practices. GC must continue to pursue its mission "Making disciples of Jesus Christ..." To accomplish this end, GC must create direction; communicate with strategic clarity; embrace healthy leadership, and maintain accountability. Members of GC must pray without ceasing; seek the presence of Holy Spirit; love one another; and ultimately, abide by His word.

3. Share briefly why you want to serve as a delegate.

Spiritual results do not happen in a vacuum. Anointed, dedicated believers are required for kingdom work. Throughout my life, I received assignments from God – some I pondered "not me Lord", some I thought I was not well prepared for. 2. What do you believe are the most important issues facing General Conference?




3. Share briefly why you want to serve as a delegate.
